With these goals in mind, we are pleased to introduce the 2026 Voluntary Financial Contributions, which directly support the funding of many enriching programs and initiatives across the school.

At Thomastown Meadows Primary School, students receive free instruction to meet the requirements of the Victorian Curriculum. While all contributions are voluntary, the ongoing support of our families plays an essential role in enabling us to provide the best possible education and learning environment for our students. Digital Learning and the iPad Program

As we come to the end of our current lease agreement it is timely that we move to align with the changes to student digital device use information that was announced by the Department of Education in a special Bulletin on Thursday October 16th.

Moving forward, TMPS will introduce an alternative model, providing a limited number of **class sets of devices** that can be borrowed and shared for classes, as needed. This change aligns with the **Department of Education's recommended digital device usage guidelines**, which outline **minimal device time for Prep to Year 2** and a **maximum of 90 minutes per day for Years 3 to 6**.

As a school, we remain dedicated to creating engaging, safe, and inspiring spaces for students to play, learn, and grow. Financial contributions from families play a vital role in helping us achieve this.

Funds raised contribute to maintaining and improving our school environment — including the continuation employment of a part-time maintenance person who ensures our grounds are well cared for.

In 2026, funding will also be directed toward:

- saving to replace the oval surface,
- update the turf area
- Enhance shade sail structures
- increase seating around the school

PARENT PAYMENTS POLICY

ONE PAGE OVERVIEW



FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
